#### BANK OF AMERICA REAL ESTATE FINANCE GROUP - Concord, California

Bank of America branch managers price commercial loans daily for clients (for example a \$10 million loan for 90 days "pinned" to the Prime Rate). Under the old system, the managers had to call one of BofA's currency traders and request a price reflecting the "up to the minute" cost for funds. Unfortunately many such requests went unanswered, irritated the currency traders and consequently many loans were lost.

During this two-year contract with Bank of America, I was lead consultant for design and build a new automated commercial lending system compliant with new banking laws to guide bank managers for construction and commercial lending worldwide. Later created a Data Warehouse of all loans to provide archival / business intelligence / marketing profiles of their lending clients.

Increased the number of loan scenarios by a factor of 50, allowed BofA to re-purpose 14 highly compensated employees, reduced the cost of loan pricing by an estimated 70%, with almost instant turnaround time.

As a by-product of this project, we discovered hundreds of illegal and improperly documented loans going back almost a decade.

Thompson Publishing is a major national publisher of technical legal books for attorneys, accountants, human resources and other professionals. Thompson Corporation wanted to begin publishing their vast library of print legal information in digital form.

Thompson funded our new Digital Media Group in California expressly to pioneer their transformation to digital delivery technology. I was one of the four principals appointed to lay create the new product line for this 50 year old company.

Because this inititive occurred several years before the advent of the "interactive internet", we were limited to publishing and distributing content on a CD-ROM, and mail out updates each month. Our system featured the novel capability to perform key-word searches (foreshadowing the Google revolution).

Our efforts were wildly successful, so successful that Thompson Publishing had trouble meeting the demand. Sales of our Digital Media products began to outpace paper-based products ten to one. By eliminating the costs of printing and shipping a 30 volume set of books, in favor of a CD set, we more than doubled the profit from each sale.
